

#### **RESOLUTION NO. 2025-02**

A RESOLUTION OF THE CALIFORNIA AFFORDABLE HOUSING AGENCY RATIFYING AND AUTHORIZING THE BOARD CHAIR, VICE CHAIR OR EXECUTIVE DIRECTOR TO ENTER INTO A CONTRACT OF SALE TO PURCHASE NINE COMPLETED HOMES IN THE VERMONT VILLA (TUSCANY VILLA) SUBDIVISION IN TURLOCK, CA THROUGH ESCROWS AT STEWART TITLE OF CALIFORNIA, INC. AND FURTHER AUTHORIZING THE BOARD CHAIR, VICE CHAIR OR EXECUTIVE DIRECTOR TO TAKE NECESSARY ACTIONS AND TO SIGN ANY AND ALL NECESSARY DOCUMENTS AND ESCROW AGREEMENTS IN ORDER TO COMPLETE THE PURCHASES AND ANTICIPATED RESALES OF THE TEN HOMES

WHEREAS, the California Affordable Housing Agency (the "Agency") is a joint exercise of powers agency consisting of twenty-two California housing authorities located throughout California pursuant to Chapter 1 Part 2 of Division 24 of the Health and Safety Code of the State of California (the "Act"); and

WHEREAS, the Agency is authorized by the Act to issue bonds, and/or finance loans and mortgages for the purpose of acquiring multifamily rental housing facilities and single-family housing units to be located within any area of operation of the Agency; and

WHEREAS, the Executive Committee of the California Affordable Housing Agency authorized staff to enter into a contract of sale to purchase ten completed homes in the Vermont Villa (Tuscany Villa) subdivision in Turlock, CA through escrows at Stewart Title of California, Inc. office at its October 14, 2024 meeting of the Executive Committee;

WHEREAS, CalAHA did execute a written contract to purchase said nine completed homes in the subdivision; and

WHEREAS, the for-sale homes are near completion and CalAHA will now authorize the signors for all of the nine escrows and all of the resale escrows.

WHEREAS, the executive team prepared and issued a resolution approving the signors authorized to complete the purchase of the first two completed homes for sale in order to keep the escrow process moving forward before another Executive Committee meeting could be held;

NOW THEREFORE, the Executive Committee of the California Affordable Housing Agency does hereby ratify and confirm Resolution No. 2025-01 and does hereby authorize the purchase of the nine homes completed and located at Turlock, CA at 571 Jason Drive, 561 Jason Drive, 551 Jason Drive, 541 Jason Drive, 531 Jason Drive, 521 Jason Drive, 511 Jason Drive, 501 Jason Drive and 530 Jason Drive in CalAHA's name and/or the name of a related entity.

The Executive Committee further authorizes its Vice Chair, Jim Kruse, Executive Director, Nick Benjamin or its Board Chair, Bob Havlicek to take all necessary actions to finalize the escrows for purchase of the nine homes and to sign any and all necessary documents and escrow agreements in order to complete the purchases and anticipated resales of the nine homes set forth herein. Any one of the three listed individuals can sign said documents and/or agreements on behalf of the California Affordable Housing Agency for any and all of the escrow closings.

The Executive Committee further authorizes and approves of the resale of the nine homes to buyers who qualify under the Trio's Link Home Loan Program or through other mortgage lender loans.

This Resolution and Authorization shall be effective as of the date signed by the Executive Committee officers.
